THE UNDERSIGNED, acting as incorporators of a corporation under the Fiorida General Corporation Act, adopt the following articles of incorporation for such corporation:

ARTICLE

The name of the corporation is: BIADES OF GREEN, INC.

ARTICLE II

The period of its duration is perpetual.
