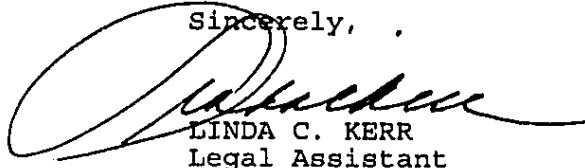

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is RENTAL ENTERPRISES, INC., and its business mailing address is 500 Fairway Drive, Suite 204, Deerfield Beach, Florida 33441.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

ARTICLE VI - INITIAL BOARD OF DIRECTORS

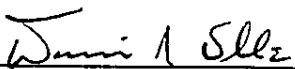
