

ORTICLES OF INCORPORATION LET ME ENTERTAIN YOU, INC.

ARTICLE I - MAME

The name of the corporation is LET ME INTERTAIN YOU, INC. with a mailing address of 8905 Victoria Place, E-3. Compand Creek, Fla. 33066.
