I, Diego Herrera, a natural person at least eighteen (18) years of age, hereby associate myself for the purpose of being a corporation under the laws of the State of Florida, by and under the provisions of the Florida Statutes, Chapter 607, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.


