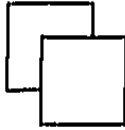

**ARTICLES OF INCORPORATION  
OF  
SHEERAZ TRADING CORP.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation is

**ARTICLE II NATURE OF BUSINESS**

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having \$1 par value per share.

**ARTICLE IV. ADDRESS**

The initial street address of the principal office of this corporation is to be at 736 S.FEDERAL HWY., DANIA FL. 33004.

The Board of Directors may from time to time designate such other address and place for the principal office of this Corporation as it may see fit.


**ARTICLE V - REGISTERED AGENT**


### ARTICLE XIII AMENDMENT

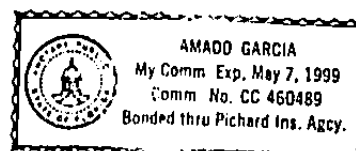
