To Whom It May Concern: This letter is to explain why we had neglected to file the 1999 Annual Corporation Report. We had moved on April 24, 1999 to Cape Coral Fl., at the time we were very much absorbed with the move. We had filed all the necessary papers with the state and city for the change of address for AMERICAN DREAM REAL ESTATE INC. all in the month of May (which I give myself a lot of credit for since there was so much paper work). During the tax season we filed and notified the IRS so we thought we covered all the necessary bases. All of our mail had been forwarded to our new home address without any problem except for the Annual Report for the Corporation, which I can not understand.

We still to this day would not have known that the Corporation had dissolved if it were not for me going to a Cellular One dealer and purchasing a new phone for the Corporation and asking to set up an account. They issued a credit check and told us that the Corporation had dissolved on Sept. 9, 1999 and I just found this out on Jan. 7th! I immediately called the BPR and spoke to a supervisor by the name of Andy Dunlap he confirmed what the women at Cellular One had told me. I asked him if we were notified and he said "yes" three times and one letter returned marked address changed. I questioned why they could not look up our new address with the licensing bureau, he said that this is my responsibility not theirs. I asked him what I should do to reinstate the Corporation. He explained the procedure and informed me of the cost for reinstatement. If I tell you I almost fainted that would not be an exaggeration!. This is all a total shock to me I told him. We are not a large company, I try to do everything right but I honestly do not think that it is fair for us to be penalized for this when all someone had to do when the mail was returned was to check to see if we were in fact still active through the Division of Real Estate and retrieve our new address via computer. After all it is the initial fees that we all pay to become a Corporation that enables this office to exist. Where is all this Reinstatement money going? As you can see and hopefully understand that by me writing to you as soon as possible that this occurrence was in no means intentional. I explained this to Mr. Dunlap and his suggestion was that I request a reinstatement form through the automated system and fill it out and send in a cover letter explaining the circumstances along with a check for the 1999 and 2000 Annual Reports and hopefully someone would understand and accept it as payment in full. So, I did call the automated system on that same day, left my information and waited. On the 12th of Jan., I called again and this time spoke with Michelle. I explained to her everything (she was very nice and understanding) about my concern not receiving the form yet and she told me that she would personally send one out in the mail. Why couldn't this courtesy be extended to me when I had called on the 7th of Jan? Time is of the essence and this is very upsetting to me. I would have taken care of this matter before it evolved into this problem and I hope that you would consider my sincerity when you reinstate the Corporation and waive the reinstatement fee.

Enclosed is a copy of the reinstatement form and a check for the 1999 & 2000 Annual Reports. I was told by Mr. Dunlap it will be \$150.00 for each.
