ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act adopt the following Articles of Incorporation for such Corporation:

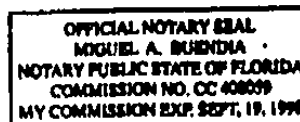
