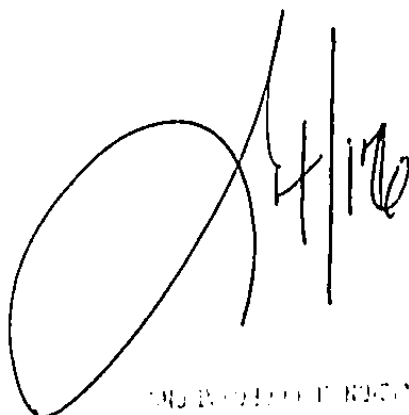

ARTICLE I

NAME

The name of this corporation is THE SOUTH END CLUB, INC.

ARTICLE II

DURATION

The duration of the corporation shall be perpetual.

ARTICLE III

Each recovering addict who wishes to stay drug-free is eligible to become a regular member of this corporation upon payment of the dues set forth in the By-Laws, rules or regulations of this corporation. Non-addicted relative and close friends of regular members are eligible to become auxiliary members with rights and privileges as set forth in the By-Laws upon payment of the dues set forth in the By-Laws, rules or regulations of this corporation.
