ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME OF CORPORATION

ARTICLE II - PURPOSE

The general purposes for which the corporation is to provide the following:

- A. To resurface, remodel or repair swimming pools, fountains, and similar structures.
- B. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purposes limits this general purpose in any work.
