

1. The name of the Corporation is TRANS-FIX SERVICE CENTER, INC. (the "Corporation").
2. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

**ARTICLE I**

The name of this corporation is **TRANS-FIX PARTS CENTER, INC.** (the "Corporation").

3. This Amendment was recommended by the Board of Directors to the Corporation's shareholders on August 28, 2002.
4. This Amendment was adopted on August 28, 2002.
