ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

DANCEHURST, INC.

ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is to be the teaching of dance lessons in the wholesale and retail market, and the promotion of dance lessons and related activities. Additionally, this Corporation shall have the power to do all things which natural persons or Corporations can lawfully do in the State of Florida.

ARTICLE III TERMS OF EXISTENCE

This Corporation shall have perpetual existence unless dissolved by action of law or voluntarily dissolved.

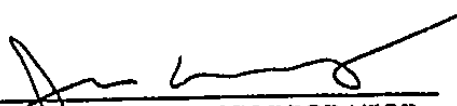
