The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

#### ARTICLE I - NAME

The name of this corporation is SUPPORT PERSONNEL, INC. whose address is 315 N.E. Third Avenue, Suite 201 - Ft. Lauderdale, Florida 33301.
