# ARTICLES OF INCORPORATION OF DT HOLDINGS CORP.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE (

# Corporate Name and Principal Office

The name of this corporation is DT Holdings Corp. and its principal office and mailing address is 350 Royal Poinciana Plaza, Suite #3C, Palm Beach, Florida 33480.

#### ARTICLE II

# Commencement of Corporate Existence

The corporation shall come into existence on April 11, 1996.

#### ARTICLE III

# General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

#### ARTICLE IV

#### Capital Stock
