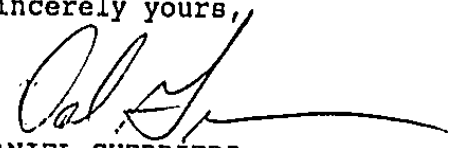

*We, the undersigned subscriber to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the Laws of the State of Florida.*

**ARTICLE I - NAME**

**ARTICLE II - NATURE OF BUSINESS**
