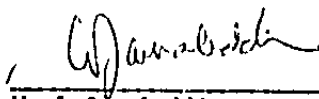

ARTICLE SIX

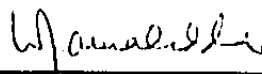

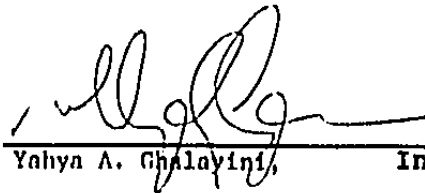
