ARTICLE VII

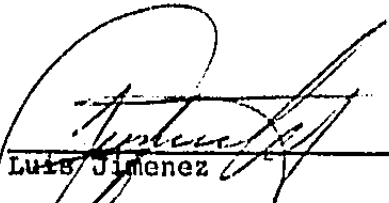

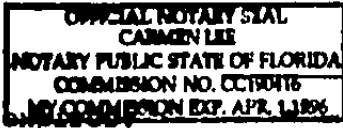
