ARTICLES OF INCORPORATION

OF

SEPULVEDA & SON CATERERS, INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Horida General Corporation Act, adopt the following articles of incorporation for such corporation:

ARTICLE I

The name of the corporation is: SEPULVEDA & SON CATERERS, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
