The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be:

The Corporation shall have perpetual existence.

ARTICLE - III

The general nature of the business to be transacted by this corporation shall be:

- A. To engage in every phase and aspect of business that a corporation under the laws of the State of Florida, is authorized to render.
- B. To invest the funds of this corporation in real estate, mortgages, stocks, bonds or any other type of investments, and to own real and personal property necessary for the operation of such corporation.
- C. - D. The foregoing paragraphs shall be construed as enumerating both objects and purposes of this corporation and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.


ARTICLE - VIII - DIRECTORS



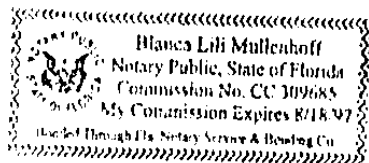
