**ARTICLE I
CORPORATE NAME**

The name of this Corporation shall be:
COMPREHENSIVE FAMILY PHYSICIANS, INC.

**ARTICLE II
CORPORATE EXISTENCE**

The existence of the Corporation shall be perpetual. Corporate existence shall begin upon filing of the Articles Of Incorporation by the department of State.

**ARTICLE III
NATURE OF CORPORATE BUSINESS**

The Corporation may engage in any activity or business permitted under the laws of the United States and under the laws of the State of Florida.

**ARTICLE IV
CAPITAL STOCK**
