ARTICLE ONE

The name of the corporation is **Financial Branches, Inc.** The principal address of the corporation is: 1844 N. Nob Hill Road, Suite 236, Plantation, Florida 33322.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**

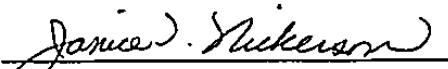
ARTICLE FIVE

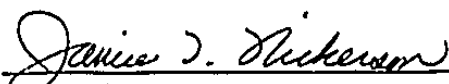
ARTICLE EIGHT
