ARTICLE I - NAME


The name of the corporation shall be: JPTS Enterprises, Inc.

3. The amendment was adopted on the 21st day of September, 1999, in the manner prescribed by the Florida Business Corporation Act by the board of directors and the shareholders.

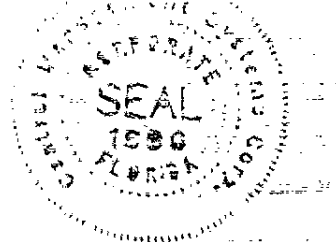
4. This Amendment shall be effective upon the earlier of March 9, 1999, or its filing with the Secretary of State as provided by the Florida Business Corporation Act.
