Fourth: No preemptive rights will be granted to holders to shares of stock of the Corporation.

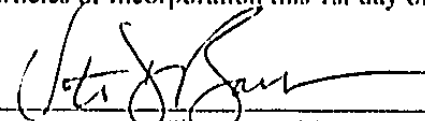

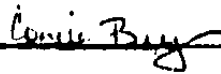
