The undersigned subscribes to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

# ARTICLE I

The name of the corporation shall be:

PR YACHTS, USA, INC.

and its principal office for the conduct of business shall be:

The Board of Directors may from time to time move the principal office to any other address in Florida.

## ARTICLE II


