ARTICLES OF INCORPORATIONS

OF

Robermaru Decoraciones Corp.

We, the undersigned, hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida, and under the statute of the State of Florida provided for the formation, rights, privileges, immunities and liabilities of incorporation for profit. It is:

TALLAHASSEE, FLORIDA

ARTICLE I

The name of the Corporation shall be; Robermaru Decoraciones Corp

ARTICLE II

The corporation shall engage in any activity or business permitted under the laws of the State of Florida and of the United States of America.

ARTICLE III

The maximum number of shares which the corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, and which common stock shall have a par value of \$ .500 per share.

All stock is to be issued as fully paid and exempt from assessment.

ARTICLE IV



