

Chapter 621, the undersigned, being a natural person qualified and licensed to practice the profession of law, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a professional service corporation.

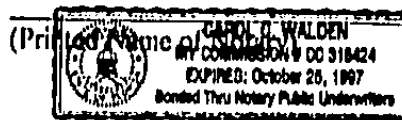
