1. Name. The name of the corporation is: \$ FOR TITLES, INC. STATE OF FLORIDA
2. Purpose. The corporation may engage in any legal business. EFFECTIVE DATE 4-5-96
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of common capital stock of a par value of \$1.00 per share.
