ARTICLES OF INCORPORATION

OF

WD GREY, INC.

The undersigned incorporator, being a natural person competent to contract, hereby adopts these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE

The name of this Corporation is WD GREY, INC.

ARTICLE II

This Corporation shall commence upon the execution of these Articles and shall exist perpetually.

ARTICLE III

The purpose of this Corporation is to perform site work and other construction services and engage in any business lawful under the laws of the State of Florida or the United States.
