OF

ARTICLE I.

NAME

The name of this corporation is Alley Legal Technologies, Inc.

ARTICLE II.

PRINCIPAL OFFICE

BYLAWS

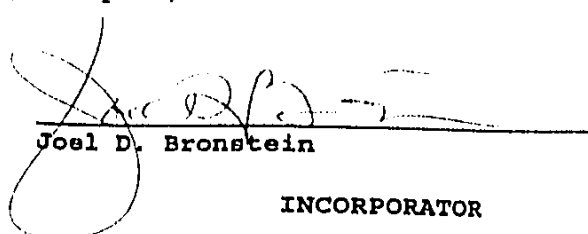
