The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation :

**Article 1. Name.** The name of the Corporation is Into **Wishin' , Inc.**

**Article 2. Duration.** The duration of the Corporation is perpetual.

**Article 3. Purpose.** The general purposes for which the Corporation is organized are the following :

A. To engage in the wholesale and/or retail sale of herbs, oils and other natural products, and to offer services in exchange for a reasonable fee such as, but not limited to, educational classes, lectures, or workshops, information and/or referral to other resources and the specialized service of intuitive consultation.

B. To engage in and transact any lawful business for which Corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this purpose in any way.

C. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable to accomplish them.

**Article 4. Capital Stock.** The aggregate number of shares which the Corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

**Article 5. Initial Registered Office and Agent.** The street address of the initial Registered Office of the Corporation is 11590 Seminole Blvd. Suite B - 4, Seminole, Florida 34648, The name of its initial Registered Agent at that address is Tina Louise Elmore.

The principal office address of the Corporation is 5800 Orange Road North, Seminole, Florida 34642.

The mailing address for the Corporation will be P.O. Box 41294, Saint Petersburg, Florida 33743 - 1294.

Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is one. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than one. 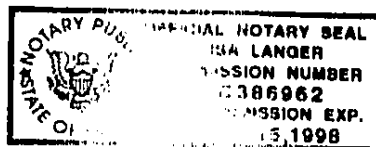

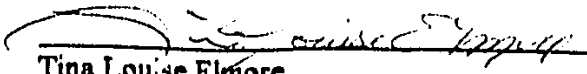
