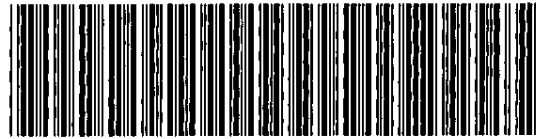

III.


