I recently received a notice of dissolution for Boiling Points, Inc. Until the time of this notice we were completely unaware of the delinquency. Boiling Points, Inc. has been established for about five years and has not nor would have any reason to dissolve itself. Traditionally we have always paid from a statement sent to us every year as a reminder to do so. From what we can figure out we never received the invoice via US mail. On October 23, 2000 I called the (850) 488-9000 to verify the claim, it was correct and was told to call the (850) 487-6059 number. I called and was instructed to submit a check in the amount of \$150.00 with an explanation of our plea to reinstate our corporation status, which I am doing now.

We also own a corporation called Transit A/C Systems, Inc. - FEIN # 59-2901632 located in Orlando, Fl. that is current with the Division of Corporations. Last year the land management co. called Lasco, Inc. has developed a new set of warehouse buildings on this property and for about a half a year we had US mail nightmare here with the new business's setting up and the mail was getting all messed up and crossed until Lasco, Inc. got it under control with suite numbers and a central mailbox. Our address did not change but all documents to Boiling Points, Inc. now have to have C.O. - Transit A/C Systems, Inc. on them. Division of Corporations must not have been aware of this according to the documents that I just received. The only reason that we received this notice is because our mailman is aware of our two companies in the same location.

With the consideration and understanding from the Division of Corporations for a mistake that obviously had been made I am asking that Boiling Points, Inc. be reinstated and that the penalty be waived. I do understand that it is the responsibility of the corporation and it's stockholders to keep all legal documents maintained and current. I am not trying to make any excuses and accept full responsibility for our corporation, I am just asking for your consideration. I will be waiting for a reply to this correspondence.
