ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator, desiring to form a Corporation for profit pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is **MAIRLOOMS**, INC. The mailing address for the corporation is 515 East Altamonte Drive, Suite 3, Casselberry, Florida 32707.

ARTICLE II - DURATION

This corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually unless dissolved by operation of law.
