ARTICLE I - NAME

The name of the corporation is INNOVATIVE HEALTH CARE SOLUTIONS OF FLORIDA, INC.

CENTRAL

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

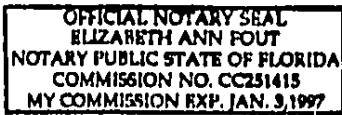
