

The undersigned subscriber to these Articles of Incorporation, desiring to form a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

I

The name of the corporation is: BRAMPTON, Inc.

II

The principal office and mailing address is 3900 Galt Ocean Boulevard, Ft. Lauderdale, FL. 33308.

III

The Corporation shall have perpetual existence.

IV

The aggregate number of shares which the corporation shall have authority to issue shall be five hundred (500) shares of common stock having a par value of One (\$1.00) Dollar per share, to be issued fully paid and nonassessable. The consideration for the issuance of shares or for the disposal of treasury shares may be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation. 
