### ARTICLES OF INCORPORATION

OF

## ALL OCCASION PLANNERS, INC.

## ARTICLE I NAME

The name of the Corporation is ALL OCCASION PLANNERS, INC. The address of the Corporation is 14408 Yakima Trail, Orlando, Florida 32837.

# ARTICLE II DURATION

The Corporation shall have perpetual existence.

## ARTICLE III PURPOSE
