ARTICLES OF INCORPORATION OF THE RICHARD L. PURTZ
PROFESSIONAL ASSOCIATION

The undersigned incorporator, for the purpose of forming a professional service corporation under the Florida Professional Service Corporations Act, adopts the following articles of incorporation:


