

ARTICLES OF INCORPORATION  
OF  
JERRY'S SPORTSWEAR, INC.

The undersigned, acting as the incorporator of this Corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, adopts the following Articles of Incorporation:

ARTICLE I: NAME OF CORPORATION

The name of the corporation is Jerry's Sportswear, Inc..

ARTICLE II: MAILING ADDRESS OF THE CORPORATION

The mailing address of the Corporation is at 9515 Southwest 148 Place, Miami, FL 33196.

ARTICLE III: DURATION OF THE CORPORATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSE OF THE CORPORATION

The purposes of the Corporation is organized to engage in any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as amended.

ARTICLE V: AUTHORIZED SHARES

#### ARTICLE VIII: INITIAL BOARD OF DIRECTORS



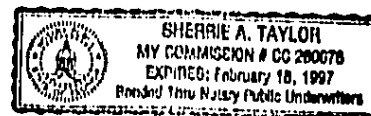


