ARTICLE I - NAME

The name of this Corporation is **WANG TRADING CORPORATION**. The mailing address is: 9410 N.W. 12th Street, Miami, Florida 33172.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence. The Corporation shall commence existence on April 12, 1996.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.10 per share.

ARTICLE VI - INITIAL BOARD OF DIRECTORS




