The name of this Corporation is MARGA OF JACKSONVILLE,
INC.

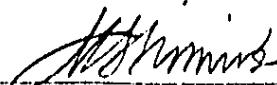

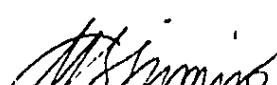
