ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is AOS OF Pensacola, Inc. Its business mailing address is 200 New Town Corporate Center, 4491 South State Road # 7, Fort Lauderdale, Florida 33314.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.

ARTICLE VI - INITIAL BOARD OF DIRECTORS





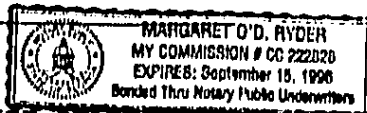
