

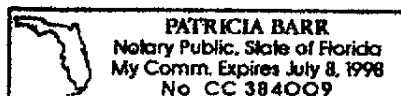
1. The name of the Corporation is: **MAJ RENT-A-CAR, INC.**
