ARTICLES OF INCORPORATION

By these Articles of Incorporation, the undersigned Subscriber forms a professional service corporation in accordance with Chapter 621 and Chapter 607, Florida Statutes, and pursuant to the following provisions ("Articles"):

ARTICLE 1

NAME

The name of the corporation shall be Thomas J. Kasica, C.P.A., P.A., and, for convenience, shall be referred to in this instrument as the "Corporation".

<u>ARTUJE II</u>

DURATION

The Corporation shall exist perpetually unless and until dissolve according to law. Corporation existence of the Corporation shall commence upon the filing of these Articles with the Florida Department of State.

ARTICLE III

PRINCIPLE OFFICE AND MAILING ADDRESS

ARTICLE V

PURPOSE AND POWERS OF THE CORPORATION
