ARTICLES OF INCORPORATION

OF

JAMES M. CHANDLER, INC.

ARTICLE I

The name of this corporation is James M. Chandler, Inc., whose principal address is 4451 SW 24th Street, Fort Lauderdale, Florida 33317.

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage as Truck driver, a business permitted under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.


