ARTICLES OF INCORPORATION OF CICCIO & TONY'S, INC.



I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

EFFECTIVE DATE

The name of this corporation shall be: CICCIO & TONY'S, INC.

ARTICLE II

Address

The address of the principal office and the mailing address of this corporation shall be: c/o Stephen C. Diaco, 101 E. Kennedy Boulevard, Suite 2175, Tampa, Florida 33602.

ARTICLE III

Existence of Corporation

This corporation shall begin existence on April 17, 1996, and shall have perpetual existence.

ARTICLE IV

Purposes

The corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE V

Capital Stock

(a) The total number of shares of capital stock authorized to be issued by the corporation shall be 10,000 shares having a par value of \$1.00 per share.
