OF

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, hereby subscribe to and form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is SUPERIOR RENTALS, INC.

ARTICLE II - NATURE OF BUSINESS

The corporation may engage in equipment rental and sales and promotion and any activity or business permitted under the laws of the United States and of this State.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one hundred (100) shares of common stock, each share having a per share value of Five Dollars (\$ 5.00).


