# ARTICLES OF INCORPORATION OF

FIBERCRETE, INC.

#### ARTICLE I - NAME

The name of this Corporation is: PIBERCRETE, INC.

### ARTICLE II - DURATION

This Corporation is to exist perpetually. It shall commence of existence on the date of filing of these Articles of Incorporation.

#### ARTICLE III - PURPOSE

This Corporation is organized for all lawfull purposes in the State of Florida.

# ARTICLE IV - CAPITAL STOCK
