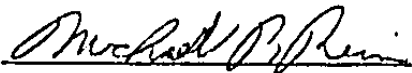

ARTICLE ONE

The name of the corporation is **3M Restaurant Development, Inc.** The principal address of the corporation is: 7770 N.W. 78th Avenue, #206, Tamarac, Florida 33321.

ARTICLE TWO

The period of its duration is perpetual.
