ARTICLES OF INCORPORATION OF WILLIAM H. McELVEEN III, D.M.D, P.A.

Article I - Name

The name of this corporation is William H. McElveen III, D.M.D., P.A.

Article II - Commencement

This corporation shall commence on April 16, 1996.

Article III - Purpose
