# ARTICLES OF INCORPORATION OF

SAFRANEK & ASSOCIATES FINANCIAL SERVICES, INC. 95 APR 22 PH 2: 34

The undersigned, acting as sole incorporator, desiring to form a corporation for the Florida General Corporation Act, adopts the following Articles of Incorporation:

# **ARTICLE 1 - NAME OF CORPORATION**

The name of the corporation shall be Safranck & Associates Financial Services, Inc.

# **ARTICLE II - TERM OF EXISTENCE**

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.
