The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is: Dels Enterprises, Inc.

ARTICLE II - ADDRESS

The address of the principal office is: 2508 Jardin Drive, Boca Raton, FL 33332

ARTICLE III - DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV - PURPOSE

The corporation may transact any and all lawful business for which corporation may be incorporated under the Florida General Corporation Act.

ARTICLE V - CAPITAL STOCK

**ARTICLE VIII - DIRECTORS**

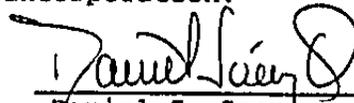
The business of the corporation shall be managed by the stockholders of the corporation rather than by a Board of Directors.

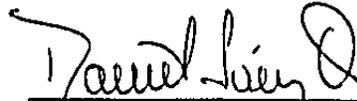
